

1 **Nevada Republican Party 2024 Platform**

2  
3 **Preamble**

4  
5 We the people of the Nevada Republican Party, affirm that this Nation and this  
6 State were founded upon the principle that all people are created equal; that the  
7 powers of government as outlined in the Constitution exist to protect the people’s  
8 God-given right to be free and to choose their own pursuit of life, liberty, and  
9 happiness; without regard to race, gender, religion, country of origin, or sexual  
10 orientation. This Platform is the result of a deliberative body that discussed,  
11 debated, and voted on the content herein, and was ultimately adopted by the full  
12 convention. We invite those who agree with the principles stated herein to join  
13 with our efforts so that this Republic will return to the principle that we are a  
14 “government of the people, by the people, and for the people.”

15  
16 **Budget, Economy, and Taxation**

17  
18 We support balanced budgets developed with zero-based budget processes at all  
19 levels of government.

20  
21 We support a free market economy.

22  
23 We support lower taxes and fees and a reduction in the scope of government at all  
24 levels.

25  
26 We support a simple, fair tax code.

27  
28 We support the repeal of the Commerce Tax.

29  
30 We support the Nevada constitutional prohibition on personal and corporate  
31 income tax.

32  
33 **Constitution**

34  
35 We support the Constitution of the United States, which includes the Bill of Rights,  
36 in its original intent, as ratified by Congress and the States.

37  
38 We charge all officials that take an oath to the Constitution under Article VI "to  
39 support this Constitution" must honor their oath as the method of enforcing it. We  
40 oppose the Nevada Legislature applying for an Article V convention.

41  
42 We support Constitutional justification for all Federal and State legislation. We  
43 believe legislation be limited to a single subject. All executive orders,  
44 administrative directives, and other rules shall emanate from a specific enumerated  
45 power in the Constitution.

46  
47 **Education**

48  
49 We support the elimination of the unconstitutional US Department of Education.

50  
51 We support maintaining an elected, rather than appointed, Board of Regents as  
52 specified by the Nevada Constitution.

53  
54 We support local control of a traditional, classical liberal curricula and oppose the  
55 testing, data collection, data mining, psychological profiling and tracking that  
56 follow students for life.

57  
58 We assert that education is a state and local responsibility, and parents have the  
59 right to choose the best education for their children, with the public funding  
60 following the child.

61  
62 We support an education system which prepares students for a successful life and  
63 meets the needs of Nevada's economy.

64  
65 We support the prohibition of biological boys and men from bathrooms, locker  
66 rooms, and spaces or sports that are designated as girls or women's spaces or  
67 sports in all schools in the United States.

68  
69 We oppose the implementation of Diversity, Equity, and Inclusion (DEI) in school  
70 policy and curriculum in all schools K-12 in all colleges and universities in the  
71 United States.

73  
74 **Elections**

75  
76 We support the Electoral College and oppose the unconstitutional national popular  
77 vote initiatives.

78  
79 We support the current, partisan primary election system, and oppose any  
80 alternative.

81  
82 We support a per voter verified paper audit trail for all electronic voting machines  
83 that must be used in the event of a recount or audit.

84  
85 We advocate proof of U.S. citizenship and residency at the time of voter  
86 registration and requiring government issued photo ID at the time of voting.

87  
88 We oppose automatic voter registration through any governmental agency.

89  
90 We oppose same day voter registration.

91  
92 **Energy**

93  
94 We support the aggressive free market development and exploitation of all  
95 domestic energy resources.

96  
97 **English as Our Official Language**

98  
99 We support legislation affirming English as the official language for conducting  
100 business at all levels of government.

101  
102 **Healthcare**

103  
104 We assert people must be free to choose healthcare that best suits their needs and  
105 beliefs according to a free market model.

106  
107 We oppose medical treatment such as puberty blockers, cross sex hormones and  
108 surgeries that will sterilize or adversely affect the health and fertility of minor  
109 children.

110  
111 We support the rights of parents as the medical decision-makers for their minor  
112 children.

113  
114 **Immigration**

115  
116 We support legal immigration from all nations, creeds, and races who assimilate  
117 and embrace the Constitution of the United States.

118  
119 We support securing United States borders and effective enforcement of  
120 immigration laws including deportation.

121  
122 We oppose sanctuary cities, counties, states, and birthright citizenship for children  
123 born of illegal aliens.

124  
125 **Limited Government**

126  
127 We assert that the powers of government must be limited to those enumerated in  
128 the United States Constitution and respective state constitutions. We support  
129 limited government, lower taxes, less regulation, and more individual  
130 responsibility.

131  
132 We assert that all public servants must live by the same laws as the public.

133  
134 We support removing local, state, and federal governments from the marriage  
135 covenant.

136  
137 **Military / National Defense**

138  
139 We support peace through strength to sustain our national defense and protect our  
140 citizens abroad.

141  
142 We support a strong Veterans Administration to ensure veterans and their families  
143 receive the care, benefits and support earned as promised.

144  
145 **Nevada Natural Resource Use and Management**

146  
147 We support the relinquishing of federal control of public lands to the state. We  
148 support multiple use of public lands.

149  
150 We oppose the taking of Nevada lands for wilderness areas, national monuments,  
151 wildlife refuges or wilderness study areas in Nevada without a vote of the people  
152 in the affected counties.

153  
154 We support mineral exploration and extraction, agricultural, ranching, and other  
155 industries necessary for economic well-being of Nevada and the United States to  
156 remain free and independent. We support streamlining the environmental  
157 permitting process.

158  
159 We affirm that water is an essential resource which must be conserved and used  
160 wisely in our arid state. We support Nevada water law as currently codified with

161 the "first in time, first in right" principle where all users are treated fairly under the  
162 law.

### 164 **Recognition of Israel**

165

166 We support Israel as a sovereign state and recognize her right to defend herself.  
167 We believe the United States should provide such assistance as is constitutional  
168 and in our interest.

### 170 **Sanctity of Life**

171

172 We affirm the sanctity of life from conception to natural death and the inherent  
173 dignity of each human being.

174

175 We oppose government funding of abortion and organizations that advocate for or  
176 provide abortions. We encourage the use of alternatives to abortion.

177

### 178 **Sovereignty**

179

180 We reject any efforts to surrender United States sovereignty either through  
181 constitutional adoption of a treaty or usurpation of the Constitution and assert that  
182 all governmental entities must defend this concept.

183

184 We unequivocally declare that the United States is a sovereign nation not subject to  
185 any international organization, court, or law.
