

Declaration of [REDACTED]

I [REDACTED], declare under penalty of perjury as follows:

1. I am a resident of the State of Nevada and was hired as a temporary employee of the election department to process ballots during the 2020 election. I was a member of the Counting Board located at 2030 E. Flamingo Rd. I started working at the Counting Board on October 12, 2020. My last day was November 8, 2020.
2. As part of my duties, I separated mail-in ballots from their envelopes and determined whether they would require duplication. When I was not separating ballots, I worked the duplication stations and auditing stations.
3. On November 7 and 8, all mail-in ballots I processed required identification of the voter to be contained within the envelopes. Most of the ID's I observed were from out-of-state. Some envelopes did not contain any identification.
4. Throughout the time I worked at the Counting Board, I observed many ballot envelopes with signatures that did not match the name of the voter. For example, pre-printed names were scratched out and other names were written on the envelope; people signed last names that were different than what was printed on the envelope; and a mail-in envelope where someone had placed a return address label over the voter's and signed the name that was shown on the label.
5. I observed return ballot envelopes where someone else claimed they signed on the voter's behalf but did not include an oath or statement inside the envelope giving the person authorization to sign.
6. I observed a return ballot envelope with the statement "husband has dementia – I am the wife signing for him." There was no oath inside.
7. I observed a return ballot envelope with the statement "I signed for my brother because he is disabled." The driver's license was from Washington. There was no oath inside.
8. Many ballots I processed on November 7 were stamped November 5 on the front side of the envelope. They did not have postage.
9. Some ballots had "no ID" handwritten on the envelope. When I brought this to my supervisor's attention, I was told to process these ballots anyway.
10. On November 8, I received two boxes of ballots that were stamped October 21 and October 22.

11. Throughout the time I worked on the Counting Board, I processed an excessive amount of return ballot envelopes with out of state addresses.
12. On November 8, I observed a return ballot envelope with the name of the voter scribbled out. I brought this to my supervisor's attention and she instructed me to reject it. This ballot had already passed the signature match and comparison efforts conducted by other employees and/or the Agilis machine.
13. On November 8, was instructed to process a box full of ballots that was not sealed at the top.
14. For the first few weeks, ballot boxes I processed were full of ballots that had been sliced open. However, there were two machines at the Counting Board that sliced opened ballots; and those machines were operated during the last week. During the last week, I was instructed to process a box of ballots that were never sliced open.
15. I processed several ballots in each box where only the only vote was for the President.
16. During lunch and other breaks, we were instructed to leave everything where it was on our desks and exit the room. The supervisors and ballot runners continued to have access to the room during breaks.
