15 **BE IT RESOLVED that the Nevada Republican Central Committee**
16 **does hereby declare as follows:**

18 **RESOLUTION PART A**

20 **Chapter 2, Subsections 2.1 and 2.3 of the Standing Rules of the Nevada**
21 **Republican Party are hereby amended as follows:**

23 **§ 2.0 Calculation and Reporting of Presidential Preference Poll Results.**

25 *Subsection 2.1*

26 a) The ballots cast for each Presidential Candidate on the Presidential Preference Poll
27 shall be tallied by precinct immediately after voting closes. Ballots must be counted
28 using only NVGOP official tally sheets, and must be retained in accordance with the
29 procedures developed by the NVGOP for record retention purposes. Official vote tellers
30 must print their name as it appears on their voter registration, provide the date and time
31 the tally was completed, and sign the tally sheets in order for the votes to be counted as
32 valid.

33 e) The vote counted at each individual Precinct Meeting is the official vote except as
34 provided for in Section 4.0. Neither the NVGOP nor any county party shall recount
35 ballots after the adjournment of a precinct meeting except in cases of a recount as
36 specified in Section 12 of this rule.

38 Subsection 2.3 – Each county central committee shall ~~[archive all ballots for a period~~
39 ~~of one year and shall provide them on request to the NRP Secretary for audit]~~ retain
40 all ballots and tally sheets, and must ship or deliver them to the NVGOP headquarters
41 within thirty (30) days of the caucus, where they will be archived for a period of not
42 less than seven (7) years. All shipping costs will be paid by the NVGOP.

47 Bylaws, which formally recommends its adoption by the Nevada Republican
48 Central Committee.
