#1 NO-To retain selection of University Regents by voters, not legislature

#2 NEUTRAL

#3 NO-Ranked Choice Voting eliminates "one person-one vote" and relies on computer algorithms

#4 YES-Clarifies no slavery or involuntary servitude under any circumstances

#5 YES-Tax reduction for beneficial purpose

#6 NO-Passage allows abortions by non-doctors in unregulated facilities all nine months and eliminates parental involvement

#7 YES-Requires government approved identification to vote
